TERMS AND CONDITIONS

Students shall....

- Use the Internet for educational purposes only.
- Communicate with others in a courteous and respectful manner.
- Maintain the privacy of their personal name, address, telephone number, passwords and respect the same privacy of others.

- Use only Internet accounts and passwords provided by the school.
- Report any incident of harassment to the supervising teacher.
- Comply with copyright laws and intellectual property rights of others.
- Acknowledge the source when using information in research projects and assignments.

Students shall not....

- Knowingly enter unauthorised computer networks to tamper or destroy data.
- Access or distribute abusive, harassing, libellous, obscene, offensive, pornographic, threatening or illegal material including e-mail.
- Install personal software on computers.
- Plagiarise—copy directly without acknowledging the author.
- Use the Internet for commercial, purchasing or illegal purposes.
- Copy or download for personal use.
- Enter and use Chat Sites.

PENALTIES

Violations of the Internet Acceptable Use Policy may result in suspension of Internet privileges, school disciplinary action, and/or legal action.
